• Community Center Task Force Update

Ann Hough stated we have had an overwhelming response to the survey.

Ashley LeClair stated the task Force met <sup>1</sup>/<sub>2</sub> dozen times. Our survey brought in 250 responses.

Mr. Deyo said it sounds like the majority wants to upkeep what we have. Sounds like common sense things.

Mr. Smith said we should move the ice skating rink due to water issues.

Ms. Cheetham-Palen said we received pictures from Schroon Lake and those were very helpful.

Mr. Biesemeyer, there is one thing that we were just made aware of last week. There is an individual, Leita Hamill, who was willing to donate \$60,000 to replace all the playground equipment. She just sent us a letter on July 28<sup>2023</sup>, in the letter

she explains what her offer was. I did not know about any of this but apparently in July of 2022 she called Joe Pete and he came to the board saying there was an anonymous donor but we didn't know any of the particulars. Then she was upset because she was told, we the Board, turned it down. There was no way on earth that I would have turned down \$60,000. Ms. Hamill had the people that engineered the playground at the Ausable Club look at our playground and looking it over he told her there are liability issues, the slide, the rings and the sandbox. I went down yesterday and looked it over, the slide has to be removed immediately. We have a serious liability here, we have to deal with this first and foremost. Mr. Smith said there is a board on the deck that has to be replaced.

Mr. Wilson ask to address Mr. Biesemeyer. You made a very incorrect statement there. I gave board members the hand drawn plan, her offer, and we did have a discussion in executive session because she wanted to remain anonymous but then we did have a public discussion about it and Bob you are quoted in that and no Board member said lets do this nobody made a resolution to do this. One of the main reason is like Donald pointed out is the water issue, to fix it correctly we have to dig up in front of the Community Center. The point I brought up to the Board and Ms. Hamill was that we are starting the process and if we put in a new playground now( last Year) there is no predicting when we address the Community Center. To go ahead and build a playground regardless of the kind offer seemed premature and that was the discussion we had. No Board members said I make a motion to build this playground.

Mr. Bisemeyer said I have no recollection and I asked Dave and he said he didn't either.

Mr. Deyo said I know her well and I would have remembered that conversation if we had it.

Vigorous discussion from several people came all at once.

Ms. Kaltenbach asked how is this helping the future of the Community Center, it happened and we are a year later.

Mr. Smith, I say put the playground down below, we should except her money. Mr. Deyo stated that offer doesn't stand anymore.

Ms. Dumas has one question, you just said that you were informed a year ago by parents of the playground ?

Mr. Wilson said that parents wanted to relocate the playground below so it was in the same location of the playing field.

Mr. Biesemeyer said all those items are fine Joe Pete.

Ms. Dumas said you don't have those minutes

Mr. Wilson said yes we do they are on-line. Bob you are quoted in those minutes. Ms. Smith, I just want to say what I recall and that was a discussion about a

donation for the playground, also at that time there was discussion about the Community Center whether to have the playground out front or out back . I know Bob had recommended to accept the playground and install it and then we can take it down and move it out back if needed. That is what I recall and after that I didn't here anything more.

Mr. Biesemeyer said he followed up with Joe Pete.

Mr. Wilson thanked Ms. Smith for clarifing that. I also want to state there were no other Board members that said let's do this.

Mr. Deyo said you said there were contingencies and you would get back to us. Mr. Wilson asked what ?

Mr. Deyo said you were getting back to us about the contingencies on the gift.

Mr. Wilson asked, I thought you didn't remember this?

Mr. Deyo said I remember a brief discussion.

Ms. Cheetham-Palen asked if we can get back to the recommendations from the Task Force. We are now in a position to move forward.

Ms. Kaltenback stated we didn't realize how much support we had

Mr. Wilson, based on the survey, it looks like we have a recommendation to move the playground down below. So now where should we move the rink, etc.

Mr. Hall stated you have a plan, now can do grants, donation, money will come in, it's just a matter of logistics.

Mr. Wilson asked if the Task force is ready to focus on the outdoors first,

playground, outdoor skating rink, bathrooms.

Ms. Dumas said the restrooms are very important.

Ms. Kaltenbach said other Towns that we went to, they did this in stages.

Mr. Biesemeyer asked if he could make a recommendation, if the Task Force and the Town Board can agree on where to put the playground, it might be worthwhile to reach out to Ms. Hamill.

Mr. Wilson anticipated the need for restrooms. We have started saving money into the reserve account, I think we have about \$100,000 there specifically for restrooms.

Mr. Deyo stated, we are at a point that the Task Force can work on those things and we can move forward.

Mr. Wilson wanted to address the point Bob brought up about playground safety. If you found something, I do go through it with our insurance every year. If you noticed we removed the jungle gym, we put new pea stone in, we have removed some equipment. If you identified the slide being unsafe I will go down tomorrow. We will either repair it or replace it.

Mr. Biesemeyer said it needs to be replaced.

Mr. Wilson told the board memebers so you are fully aware if we can't repair or replace the slide we will take it down and close off the opening.

Mr. Biesemeyer will see if he can find a slide.

Mr. Wilson thanked the Task Force for all their work.

• Keith Hall asked for privilege of the floor. I have a couple things. We have informally submitted this and now we are formally submitting our review of the proposed law for the STR and have a petition for using the registration vs the stand-alone law.
