### Playground Attachment #-1-16

Mr. Biesemeyer explained this is to look at seeing if we want to take advantage of the offer Mrs. Hamill wanted to give us of \$60,000 to replace the playground equipment. Kirk Baughman represents the company that does the installation and sells it.

Mr. Wilson stated you did the playground at the Ausable Club.

Mr. Biesemeyer, also Town of North Elba. With the regards to the playground equipment, the offer was off the table for a while because there is a Community Center Committee, somewhere it was thought not to take the offer but there was miscommunication. After some discussion, Ms. Hamill is willing to supply the equipment. The cost to do {see attached} this is all well within the scope of the offer.

Mr. Baughman, yes and it includes many other things within that. It includes renovation of the Ring Climber. We do not see the sense in eliminating something that is still useable. That does not apply to the slide.

Mr. Deyo, I think our main concern is if we decide to take it down and move the playground is it feasible?

Mr. Baughman, it surprisingly is. There are no posts in the ground, you can see the base timbers it is attached to.

Mr. Wilson asked to hear from the committee.

Ms. Kaltenbach, I am not against the idea. Can we get an ADA complaint swing? How long do the timbers last compared to the metal?

Mr. Baughman, yes we can install an ADA swing but you would lose a bay of swings. We have installations out there that are 25 years old. The treatment used on the timbers is a nontoxic pressure treatment.

Mr. Smith, how much to move it.

Mr. Baughman, they have to pay prevailing wage, but it can be done in house.

Ms. Cheetham-Palen, does the surface come with it?

Mr. Baughman, no but there are options, woodchips, which would be about 2 loads for \$3,500 a load, or sand.

Mr. Biesemeyer, as far as timeframe what is the earliest?

Mr. Baughman, it takes 60 days from approval. I talked to the owner and if you place the order within 60 days then you protect the price, you are locked in.

Ms. LeClair, is the donor ok if it has to be moved in the future?

Mr. Deyo, yes she is ok with it.

Mr. Wilson wants to make sure the members with the task force are ok with this.

Mr. Deyo, maybe we have the Task Force get back to us by the next meeting.

Mr. Baughman asked to go on record saying he would help move it for free.

Mr. Wilson, I will put this on the agenda for October 31st.

### Jane Haugh Update from ADAC Attachment #2-16

We got feed back on the Dear Neighbor letter.

The 1<sup>st</sup> question is the cost for a direct mail to every mailbox in Keene and Keene Valley. The total cost would be \$336.00. We wanted to know if we could apply to the fund to cover this cost?

The 2<sup>nd</sup> question is what does the board think about the way its signed, "a committee of the Keene Town Board"? Wondering what everyone thinks about the language of this?

Mr. Biesemeyer, I don't see a need for this letter. My fear is it will antagonize people.

Ms. Haugh, we have had people call State Troopers on people of color when they been in the wrong place. Somebody called the police in Westport because someone was trying to get water from the golf course pond.

Mr. Biesemeyer, do you think this letter in our mailbox will help?

Mr. Deyo, who are we mailing this to?

Ms. Haugh, Keene and Keene Valley.

Mr. Wilson, I have a thought, using this for our training of the backcountry stewards.

Ms. Haugh, I feel we need to be proactive.

Mr. Stephan Hall. I am perplexed, I am a long time resident here and I don't know how these people feel unsafe.

Ms. LeClair, maybe not a mailing, maybe put it on the website, maybe have a section of questions and answers.

Mr. Deyo,I like Ashley's idea, I think we need to get this to the people coming in, I do not think it is the residence here.

Ms. Cheetham-Palen,I am ok with the letter and with the ideas that were suggested here. Another option is maybe make the hospitality people aware of this.

Mr. Biesmeyer, I want to add that my son-in-law is from Venazwhala and his parents come for up to two months ever summer, they don't speak very much

English, the Mountain House has had a huge clientele for over 76 years and not one person has ever complaint about being mistreated.

Ms. Haugh, I want to mention that Kathy Hochul has started a Hate Crime Prevention Council. I am on that council, there is interest, and creating a broader ally by using a training, that SUNY Plattsburgh has started using with their Professors. They are interesting in bringing it to Essex County Board, what do you think Joe Pete?

Mr. Wilson, I need to think on that, I will get with you on this.

Mr. Daly wanted to suggest a few practical things. You asked at the onset about referencing the Town on the letter as a subcommittee of the Board, I would take that out, it's not a sub-committee of the Town of Board.

Ms. Cheetham-Palen, it came out of a resolution.

Mr. Daly, that does not make it a sub-committee.

Ms. Cheetham-Palen you are right it's not a committee.

Mr. Daly, second point I think given everything you have described any funding should come from the Roost money.

Mr. Wilson, I want to follow up with you Jane on the recreation sites for this letter.

Mr. Wilson asked anyone else had anything?

Mr. Smith asked for a light for the flag out in front of the Town Hall. Another thing is the banner in Keene Valley is upside down, can we take care of that. Then the speed sign does not work. The welcome sign on the Jay side is smashed.

### New Trails Update

Mr. Wilson said we are planning a grand opening at the FEMA Park and the name is going to be **Linda's Loop**.

Ms. LeClair said we have a main trunk trail, it's all grass, then a path about 1/5<sup>th</sup> of a mile through the woods.

Mr. Wilson said we are aiming for the 28<sup>th</sup> of October for this opening. Also planning opening for the upper section of the Town trail at Marcy Field.

### • Adopt Fund Balance Policy Attachment #3-16

Mr. Wilson said he does not want to adopt the Fund Balance Policy yet. I am trying to come up with a way that we always have enough money to cover the Health Saving Account. On the last page where the appropriations for the unassigned Fund Balances are, I added a new number 1, which is if the Health

Reimbursement is in deficit use Fund Balance to replenish the account. I do not want to vote on this tonight we want to talk to Kathy Friday to get her thoughts.

Mr. Daly thinks that maybe Liam could look into this because I do not think you can use Fund Balance for recurring expenses.

Mr. Wilson stated he is not looking at this for recurring, more of a safety net.

#### **New Business:**

### • Cemetery Requests

Mr. Wilson said we are going to move this to October 31<sup>st</sup>. Ann and I will compile the requests we have and then get those to Board Members to look over. We will then discuss them in executive session because I feel there may be private information and then vote in public session.

### • Ongoing Local Law Process:

Mr. Wilson stated Liam sent us the revised draft of the proposed STR Law at the last meeting, not everyone had time to read it.

Mr. Daly the only thing I have is typos which I can give to Liam. I do think which might be helpful is if we could generate a black line showing the revisions from the very beginning to this current draft. I think over the last 10 months we have made a fair amount of changes and I think it is important for people to see these. We have taken the suspension of permits away from the Code Enforcement Officer and put it to the Town Board, we have modified the appeals process, we cut the penalties in half, we removed the criminal violations, we watered down the septic and a few other things. I think for the people to see these changes it would be helpful if Liam could create a black line.

Mr. Biesemeyer, I still think this a huge, huge, mistake to make this a law.

The task force gave us the four steps in the registration plan, which was given to us in February 2022 as an end of the Strategic Plan. We as a Board accepted that to move forward but we never took it to the public. We had on the table a milder version of this. There is still so much in this law that I think will be challenged. What I have learned from the STR, I think they create more benefit then harm to our community. Last year they generated \$77,000 into Roost and this year we stand to gain \$100,000. There are many people that have STR's who benefit from the income.

Mr. Daly, there is nothing in here that says they will not still benefit.

Ms. Cheetham-Palen,I want to speak to this. We have had a lot of time to listen and go through this in workshops and you did not want to work.

Mr. Biesemeyer said the first workshop was an hour, I did not have a whole day. I saw all the recommendations and I knew there was no way we could do that in an hour we needed a special workshop.

Ms. Cheetham-Palen said we had more than one workshops.

Mr. Biesemeyer said it has not help in the law, or changes.

Mr. Hall said there has been changes.

Mr. Daly, we took feedback from the public and we made changes. That is what we did, that is more then what happened at our workshops.

Mr. Wilson, we will have Liam do the black line for this.

Mr. Hall said the original survey "What does the Town of Keene feel are the most important problems". Well the affordable housing and STR's were a signal line item. Affordable housing is a nationwide problem and everyone, most everyone is concerned about it, so the two of those being on the same line was wrong. They are different items. The item that failed to make it to the top five was taxes and equality. The other piece is the survey was available to everybody and anybody. There was no control of who could fill out the survey and you could do it 5 days a week if you wanted to. There was no control over who filled it out. On the other hand, the petition we turned in was thrown out because they were not tax roll members.

Mr. Wilson, may address that, your petition was not thrown out, after reviewing it we saw Labron James signed it and I think maybe 15 were tax payers in the Town. Mr. Hall, I wanted to point out the survey was not too a certain population and the two together should have been split.



Dear Neighbor,

As you may have noticed, our beautiful mountain home is welcoming people who have not been visitors or residents of the Adirondack Park in the past. We believe this more open and accessible park benefits us all. In an effort to welcome our fellow citizens, below are some things to think about.

#### People coming from an urban/city life:

<u>Do not always feel comfortable sharing where they are from.</u> "Hey, where you all from?" is a way of connecting but can also be seen as a way of categorizing people in a hierarchy.

<u>Don't often trust systems we take for granted.</u> While our drinking water is amazing, many cities' tap water has turned out to be toxic. People often prefer bottled water while we take for granted the wells and water systems that bring us this gift from the earth.

May be worried about getting food they like to eat. If you have only eaten food that comes packaged, you might not trust a carrot with a bit of soil on it or an apple with the peel still on it.

May have grown up with different understandings and customs. Our ways serve us pretty darn well, but if you are coming here for the first time, how do you know the brown signs are trailheads? Or where it is safe to park? Or that you can serve yourself coffee (is it free then?). Or where the sales person is at the veggie/syrup stand -- wait... you make your own change and put the payment in a box?

Have different ideas about personal vs public property etc. In the city if you care about it you lock it up. If it isn't locked, the owner doesn't care about it. Private spaces are gated (that's how you know they are private). Open spaces are for everyone to use – uh... that's someone's lawn? A place to play a game (golf)? A meadow for grazing? An airfield!?

This is not meant to be a comprehensive guide nor do urban peoples act the same all the time. And as you can see, there is a LOT of room for confusion -- on both our community members' and newcomers' part. So let's be <u>curious</u> instead of suspicious. Let's assume good intentions. And let's ask sympathetic questions before calling on the authorities.

**Fund Balance Policy** 

Draft August 2022

The purpose of this policy is to enhance long-term financial planning and mitigate the risks associated with changes in revenues due to economic conditions the town faces. These policies also guide the allocation of sufficient monies for the purchase of capital equipment, construction of capital improvements, meeting match requirements for grants, and unanticipated expenditures that may occur. Unrestricted reserve balances may be utilized for emergency expenditures, annual budget shortfalls, or other approved projects.

The fund balance of the Town's General Fund, Highway Fund, Library Fund, and water district funds have been accumulated to provide stability and flexibility to respond to unexpected adversity and/or opportunities. The objective is to maintain an unrestricted fund balance suitable for the most efficient operation of each fund. Town finances will be managed so as to maintain balances of the various funds at levels sufficient to mitigate current and future risks, such as revenue shortfalls and unanticipated expenditures, ensure stable tax rates and user fees, and protect the Town's creditworthiness.

**General Fund:** \$700,000

The General Fund needs a significant fund balance to respond to emergencies and leverage grant opportunities.

**Highway Fund:** \$100,000

The Highway Fund needs a significant fund balance to respond to emergencies and leverage grant opportunities.

**Water District #1:** \$10,000

**Water District #2:** \$20,000

The water districts need to be able to respond to emergencies and to leverage grant opportunities. This level of fund balance helps to protect residents in each district from

fluctuating rates.

Library Fund: \$5,000

The library needs to meet unexpected expenses. Otherwise, it can rely on the General

Fund for emergencies or capital projects.

**Unassigned Fund Balance** 

The unassigned fund balance shall be any remaining amounts left within the above

listed funds. At the end of the year, if there are unexpended funds above the fund

balance limits set above, the Town will spend these funds in the following order:

1. If HRA is in deficit, use fund balance to replenish the HRA account.

2. On projects from the asset management plan or deposit into a reserve fund based

on the asset management plan.

3. Apply to debt

4. Balance the following year budget

If, at the end of a fiscal year, the fund balance falls below the established amount for

each fund, the Town Board shall take action necessary to restore the unreserved,

undesignated fund balance through the budgetary process to acceptable levels within a

reason able time frame.

This policy will be reviewed annually during the organizational meeting in January. This

policy has been adopted August xx, 2022.
