Mr. Slocum stated to diffeneciate it from the other one.

Mr. Wilson said what we are trying to do is to collect enough money to cover the cost of building the cemetery and the perpetual care is to cover the maintenance of it. Let me give you a run down,

Traditional Burial Plot, you can be buried in a casket and have a headstone, two caskets can be buried here.

Natural is each plot for one body, perpetual care is less because it does not need to be mowed every 4-5 days.

Cremation plot can accommodate 4 urns and also perpetual cost is less as well. Do you all feel ready to approve the name and rates?

KEENE'S NEW NORTON BROOK CEMETERY

Proposed Fees

November 2023

BACKGROUND: The Keene Cemetery Advisory Committee recommended a plan for the new Norton Brook Cemetery which was adopted by the Town Board in December of 2022. Since then, the Town has worked to develop and survey the three distinct sections of the cemetery: Natural Burial, Cremation, and Traditional Casket. That work is now complete, along with an access loop road, and the plots can soon be offered for sale.

In order to recommend a pricing plan for the new cemetery, the Advisory Committee took into account the capital cost of developing the area*, current and projected maintenance expenses and past history.

PROPOSAL:

Traditional Burial Plot \$750 & Perpetual Care \$750 Natural/Green Plot \$750 & Perpetual Care \$500 Cremation Plot \$750 & Perpetual Care \$500

The cost of plots in Keene's Norton Cemetery was last increased 15 years ago, when the price was raised from \$200 to \$250.

- -The proposed increase recognizes increased costs associated with maintaining the cemetery (Labor and equipment), and a portion of the cost the Town incurred in developing this expanded cemetery. The capital expense is approximately \$50,000 as of this writing.
- -The Town has used previously allocated reserve funds to underwrite the capital costs to date and will continue to use regular town funds to pay for maintenance of its cemeteries.
- -The cemetery budgets adopted by the Town Board for 2022 and 2023 were approximately \$14,000, more than \$10,000 of which was for the personnel doing the mowing and clipping.

Each Natural Burial Plot is 4' x 10' and will be for one body only.

Each Traditional-casket plot is 12' x 10' and will accommodate two casket burials, or one casket and up to 4 cremation urns.

Each cremation plot is 6' x 4' and will accommodate up to 4 cremation urns.

OPTIONS:

-Because the Natural Burial Plots have room for only one grave each, the committee recommends that the Town institute a discount plan allowing a family to buy a second Natural plot at half price. (The Perpetual Care fee would remain at \$500 for that second grave.)

-The Town should review the pricing plan on a regular basis, rather than waiting 15 or more years.


NEXT STEPS: The Cemetery Advisory Committee will prepare an information sheet for members of the public, particularly for people and families interested in purchasing space in the new cemetery. This will explain the rules for the three different sections of the cemetery and pricing of plots.


The Committee is also working on additional design plans, signage, plantings, and so forth.

I am writing as the Keene Community Garden Coordinator to submit a proposal for funds from the "Community Enhancement Fund".

The Keene Community Garden has been operating for over 15 years. We have 35 garden plots with about 25 active gardeners. The garden is evidence of a vibrant community committed to local agriculture. The variety of plants and flowers additionally serve as a wonderful habitat for our pollinator population, as well as, a beautiful and diverse piece of our community hub at Marcy field.

The garden measures 175' x 50'. The protective fence around the garden is failing and after a variety of fixes over the years, it is now in need of full replacement. We are very mindful of the aesthetic beauty of the garden and the structures to support it. We are proposing to replace the existing fence with one made of 3-4" natural cedar post, spaced approximately 10' apart. Covered with a wire deer fence. The existing doors and corner posts would remain and be incorporated into the new fence. We would utilize our volunteer group for removal of the old fence and as assistants for the install. The following is a list of the material and labor costs for the proposed project:

9' cedar posts, 45@\$10 each= \$450 500' of wire deer fence= \$2250 Labor/prep/post hole digging/installation=\$3500
