Privilege of the Floor:

Mr. Glover from Bark Eater Trails Alliance, and East Branch Community Trails, came to thank the Town for the support the Town has given them. Glen also wanted to update the Town on what they have done:

- -Opened 4 new trails, 2 miles of trails.
- -They also created a skills trail, which is kind of a 5th trail, it is a playground with little technical trail features that kids and/or new riders will be able to have fun on.
- -BETA has applied for a smart growth grant and hoping they get this then they will be able to complete all the work. In that, application is extending the parking area, finishing the trails, and working with DOT to ensure safety crossing over 9N.
- -In 2026 they will be building a series of jump lines that kids are excited about or they will be building two more trails up to the height of the project.
- Mr. Biesmeyer asked one question and that was if there were problems with restroom facilities.
- Mr. Glover stated they were lucky they had a donor step up to furnish a Porta John.
- Mr. Glover then added the trailhead for the Jackrabbit is going extremely well.

The Town took care of the clearing, grading, and surfacing of the parking lot, and BETA has taken responsibility for clearing off the trail itself. The entire project will be done before the snow flies.

Mr. Wilson added that the Highway did the work and a donor paid making this a revenue generator for the Town. It was a good partnership all the way around.

Mr. Wilson then reminded everyone that we have a Public Hearing set for November 6th, 2025 at 5:30 P.M. for the 2026 Budget.

Mr. Wilson then shared that the Ausable Freshwater Center has received a 2025 NYS Adaption and Innovation Award for their East Branch Restoration Plan. They would not have received this without the Town of Keene and Jay's support.

Dear Council Members and Supervisor Wilson,

Thank you for the opportunity to resubmit our proposal following our productive conversation on October 15, 2025.

Little Peaks Preschool & Early Childhood Center respectfully requests funding from the Town of Keene Community Enhancement Fund (CEF) to support a mission-critical project: the implementation of a shared, values-driven curriculum led by Education Support Specialist Dr. Katherine Norman. This grant would serve as part of the "first-dollars-in" needed to unlock a generous "last-dollars-in" challenge grant from The Cloudsplitter Foundation.

Request: \$10,000

This request aligns with CEF priorities outlined in the 2023 Essex County Occupancy Tax Revenues Guidance and adopted by the Keene Town Council on 2/13/24, particularly with regard to strengthening the local economy, supporting tourism, and enhancing community infrastructure.

Why This Project Matters

Economic Impact:

Little Peaks is one of Keene's larger and fastest-growing year-round employers. Of our currently 21 staff members, 60% live in Keene and/or send their children to Keene Central School (KCS). We employ 3 recent KCS graduates and offer competitive wages, health insurance, paid time off and training, professional development support, and other family-friendly benefits. Our employment opportunities support working families and help retain young, as well as experienced, professionals in the region.

Tourism & Recreation Support:

Our new summer drop-in program—launched in 2025—offers flexible, high-quality child care for visiting families during July and August. This past summer, 20 families took advantage of this resource; 4 families have already asked to put down deposits for next summer; 5 families continued from summer into the 2025 - 2026 school year, creating an excellent pipeline from summer enrollment to preschool enrollment to KCS enrollment; 1 family relocated to Keene earlier than planned due to this program's availability; and we turned away approximately 10 families because demand exceeded the availability of open seats. With Dr. Norman's guidance, the summer drop-in program is designed to align with our new core curriculum while directly supporting the town's tourism- and recreation-based economies.

Mission Alignment:

Little Peaks is rooted in the arts, literacy, and the natural world—closely mirroring Keene's identity as a recreation-focused community. Our curriculum fosters a deep connection between children and the outdoors, ensuring that the next generation grows up with the values and skills to engage meaningfully with the Adirondacks. This project is central to our ability to expand this mission in a sustainable, measurable way.

Why Now

We undertook this special project in response to a pressing need. The Cloudsplitter Foundation's investment affirms the vision and potential of this project. A \$10,000 grant from the Town of Keene will not only help unlock additional funds; it will help ensure that Little Peaks remains a vital part of Keene's economy and community fabric.

Thank you for considering this request. We are proud to be part of Keene's continued commitment to working families and young children, to developing career pathways in young and experienced professionals, and to strengthening recreational and economic vitalities in our town.
